1. Complete the Donations of Publicly Listed Securities – Brokerage Information form and deliver it to your broker or financial advisor with a copy to Broadmead Care. You may need your advisor's assistance to complete this form.
2. Your broker should contact our custodian, Scott Aitchison at CIBC Wood Gundy, and send both the completed form and the securities directly to him.
3. Once the securities have been transferred into Broadmead Care's brokerage account, Scott Aitchison/CIBC Wood Gundy will advise us in writing of the receipt of the securities and the closing market value on the day the securities were received into our account.
4. You will receive an official tax receipt for the value of the securities as determined by CIBC Wood Gundy.
5. It is Broadmead Care's policy that securities, once received, may be sold or added to the society's investment account in accordance with our financial policies.
6. Complete the Donor Direction form and return it to Broadmead Care.
